Notice is hereby given by the persons whose names appear hereon of their intention to circulate the petition within the City of Watsonville for the purpose of amending the City of Watsonville General Plan to extend the existing voter approval requirement for amendments to the City's Urban Limit Line to November 3, 2040.

A statement of the reasons for the proposed action as contemplated in the petition is as follows:
