In answering Member García, Parks & Community Services Director Calubaquib spoke about expanding use of available park space through the City's joint use agreement with Pájaro Valley Unified School District. He added staff was exploring available parcels for potential additional parks.

Parks & Community Services Director Calubaquib, in answering Member García, stated staff

would post a publicly accessible chart detailing the various fees on the City's website. In answering Member Dutra, Parks & Community Services Director Calubaquib stated the impact fees would apply to all residential housing.

Consultant Colgan, in answering Member Dutra, stated the fees being considered were common in other cities.

Parks & Community Services Director Calubaquib, in answering Member Dutra, spoke about potential impacts of fee increases on future developments and stated staff considered different scenarios with varying fee percentages before they take a recommendation to Council.

Yesenia, District 7, spoke in support of the item. She spoke about potential ways to address the need for increased park space within the City.

Bernie Gomez, District 1, spoke in support of the item and the importance of Parks & Community Services. He spoke about the potential for redistributin of the General Fund to allocate a greater percentage to Parks & Community Services.

Special Projects Director Wilson provided additional details regarding additional land constraints that posed challenges for the development's advancement.

Principal Planner Orbach, in answering Member García, spoke about the potential impacts of the initiative on the number of housing units projected in the 2030 General Plan.

In answering Member García, Principal Planner Orbach stated the initiative did not address the potential restoration of the Redman Hirahara Farmstead requested by some residents. He added the property was not within City limits.

Principal Sigman, in answering Member García, spoke about the City's land supply available for development in comparison to the Regional Housing Needs Allocation state requirement.

Sam Earnshaw, District 7, spoke about the goals of the initiative and stated concerns with the Elections Code Section 9212 economic impact report. He spoke about potential ways to address housing needs within current City boundaries.

Bob Culbertson, Committee for Planned Growth and Farmland Protection, spoke about potential areas in which housing could be developed.

Javier Zamora spoke about possible negative impacts of developing on farmland and the ability to continue infilling to meet housing needs.

Arnett Young, Santa Cruz County Farm Bureau President, spoke in support of farmland preservation and the potential negative impacts of developing on agricultural land.

Jerry Thomas spoke of the value of local agricultural land and in support of its preservation.

Amy Newell, District 1, stated her concerns with the 9212 economic impact report prepared by staff. She spoke about the importance of objectiveness in the report.

Karina Moreno, District 5, spoke about concerns with the 9212 economic impact report and potential effects of opening the urban limit line.

Yesenia, District 7, spoke about the possibility of annexing smaller plots of land to increase housing options and the negative impacts of urban sprawl on the wetlands.

Carolyn Rudolph, Santa Cruz restaurant owner, stated her business depended on locally grown produce and the importance of protecting agricultural land.

Adam Bolaños spoke about the importance of preserving farmland and potential for economic growth.
