**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AWARING CONSTRUCTION CONTRACT TO C2 BUILDERS, INC., A CORPORATION, FOR FIRE STATION 1 WINDOW REPLACEMENT PROJECT, NO. CB-21-05-QB, IN THE AMOUNT OF \$107,500; AND AUTHORIZING CITY MANAGER PRO TEMPORE TO EXECUTE CONTRACT**

**WHEREAS**, pursuant to Title 7 (Public Works) of Chapter 14 (Public Works Bid Requirements) of the City of Watsonville Municipal Code, the City issued a notice inviting bids and bids were received for the Fire Station 1 Window Replacement Project No. CB-21-05-QB. The project (less than \$200,000) was processed as an informal public works bid under the Californian Uniform Public Construction Accounting Act; and

**WHEREAS**, bids that were submitted by the deadline, were publicly opened in the “Conference Rooms A and B”, City Hall, 250 Main Street, Watsonville, California, on Tuesday, March 15, at 11:00 A.M., and later tabulated by the Purchasing Officer for the consideration of the City Manager Pro Tempore and submission to the City Council; and

**WHEREAS**, the City Manager Pro Tempore has recommended that the bid from C2 Builders, Inc., a corporation, [Contractor License #992630], for the Fire Station 1 Window Replacement Project, No. CB-21-05-QB, in the amount of \$107,500, be accepted as the lowest responsible and responsive bidder.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:**

1. This action is exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with CEQA Guidelines Section 15378(b)(5), in that adopting a Resolution awarding contract to C2 Builders, Inc., does not meet CEQA's definition of a “project,” because the action does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect

physical change in the environment and if a “project,” is exempt under the “common sense” exception (14 Cal. Code Regs. § 15061(b)(3)) because it can be seen with certainty that there is no possibility that this action may have a significant effect on the environment.

2. That the construction contract is hereby awarded to C2 Builders, Inc., a corporation, for the Fire Station 1 Window Replacement Project, No. CB-21-05-QB, in the amount of \$107,500, in the form on file in the Office of the City Clerk.

3. The City Manager Pro Tempore is hereby authorized and directed to execute said construction contract for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager Pro Tempore and the City Attorney.
